

SOUTHWEST FUEL SYSTEMS LLC

SERVICES WARRANTY

Southwest Fuel Systems LLC herein after referred to as SWF represents and warrants that its repair services shall be free from defect in workmanship under normal operating conditions on overhaul components for twelve (12) months from ship date **OR** 1,000 flight hours, whichever comes first, and repaired components for six (6) months from ship date **OR** 500 flight hours, whichever comes first. However, SWF does not warrant its workmanship against damage or loss caused by negligence, misuse, modification or misapplication of any part or fuel control unit, power turbine governors or turbine engine accessories. SWF liability for breach of its warranty here under is limited to the repair or replacement of defective parts and the customer expressly waives any and all rights it might have to special or consequential damages.

THERE ARE NO OTHER REPRESENTATIONS OR WARRANTIES OF SWF WHETHER EXPRESSED OR IMPLIED, NOR ARE THERE ANY IMPLIED WARRANTIES OF MERCHANT ABILITY OR FITNESS FOR ANY PARTICULAR PURPOSE AND WHETHER IN LAW, IN TORT, OR UNDER CONTRACT.

The responsibility of SWF under this warranty is further limited by the following conditions:

- A. Part defects must be discovered before the 12 months or 1,000 flight hours on overhauled components, or 6 months or 500 flight hours on repaired components, and SWF is given prompt notification in writing at the time such defects are discovered.
- B. The fuel control unit, power turbine governor or turbine engine accessories has been specifically maintained and operated in accordance with the original manufacturer's manuals or other expressly approved written instructions and the fuel control unit, power turbine governor or turbine engine accessory or component parts have not been repaired or altered outside of the SWF facilities in any way which may impair its safety, operation or efficiency and have not been subjected to misuse, neglect, accident, or damage by the elements.
- C. The fuel control unit, power turbine governor or turbine engine accessories or component parts are returned to SWF facilities, freight prepaid, after written notice of failure has been given SWF is afforded the opportunity of performing corrective work at its facilities at Stroud, Oklahoma.

THERE ARE NO WARRANTIES THAT EXTEND BEYOND THE DESCRIPTION OF THE FACE OF THIS CERTIFICATE HEREOF.
